This letter transmits our report of the routine resident safety inspection by Mr. J. Beall at the Beaver Valley Power Station in Shippingport, Pennsylvania. The reporting period covers from October 20 - November 30, 1990. The inspection consisted of document reviews, interviews and observation of activities. The findings were summarized and discussed with you and members of your staff at the conclusion of the inspection.

During this inspection, one non-cited violation was identified involving the failure to follow a procedure. This occurrence was an isolated event of minor safety significance and because of the adequacy of the corrective actions taken, the violation is being classified as a non-cited violation and no reply to this letter is necessary.
