The purpose of this modification is to provide CY-1991 funds in the amount of \$36,600 for EM and TLD monitoring programs at Davis-Besse Nuclear Power Plant and Perry Nuclear Power Plant. Accordingly, the following changes are hereby made:

1. Under Article V - CONSIDERATION AND PAYMENT, Paragraph A., Consideration, paragraph 3., is revised to read as follows:

"3. The amount presently obligated by the Commission with respect to this Cooperative Agreement since inception is \$227,712.50."
