This refers to the routine safety inspection conducted by Mr. G. Napuda of this office on August 24-27, 30, 31 and September 1-3, 1982 of activities authorized by NRC License No. DPR-16 and to the discussions of our findings held by Mr. Napuda with yourself, Mssrs. J. Frew, and N. Kazanas and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Our inspector also verified the steps you had taken to correct the Violations brought to your attention in letters dated June 9 and September 24, 1981. Our inspector also reviewed the status of corrective action described in your May 18, 1982 letter in response to our letter dated April 12, 1982 (Item A only). We have no further questions regarding your actions at this time.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
