Dear Mr. Gerdeman:

We have reviewed Plateau Resources Limited's (PRL's) inorganic chemical groundwater data report entitled "Addendum to Interim Report -Preoperational Environmental Monitoring Program - April 1982," which was submitted by letter dated May 26, 1982. This report was requested by NRC to satisfy preoperational environmental monitoring data requirements for the Shootaring Canyon Uranium Project. We have found the reported program to be basically in accordance with PRL's approved Environmental Monitoring Program. However, several items have been identified in the NRC review of your report (see attached memorandum - T. E. Fleming to Docket File No. 40-8698 dated August 27, 1982) as needing further input from PRL.

The items that were identified as needing further input were discussed in a phone conversation between Mr. D. Allen, PRL, and Mr. T. Fleming, NRC, on August 25, 1982. As a result of that discussion, Mr. D. Allen submitted, by letter dated September 13, 1982, the commercial laboratories' Lower Limits of Detection (LLDs) along with a probable explanation for two pH data outliers (Wells RM-1 and RM-2). This information has also been reviewed and considered in the following items which still need further input from PRL.

The following data appear to be outliers and should be checked and confirmed by PRL. An explanation should be provided, if available. or these data points will simply be disregarded as spurious.

- Chemical seep water quality data should be provided.
