Gentlemen:

This refers to the letter dated August 31, 1982 from the Sacramento Municipal Utility District in response to the Notice of Violation and Proposed Imposition of Civil Penalties sent to you with our letter dated June 24, 1982. Our letter concerned violations examined during our February 11 through April 28, 1982 inspection conducted at the Rancho Seco Nuclear Generating Station.

After careful consideration of your responses, we have concluded for the reasons given in the enclosed Order that the violations occurred as set forth in the Notice of Violation and Proposed Imposition of Civil Penalties. Furthermore, the criteria for categorizing severity levels, as defined in the Enforcement Policy (10 CFR Part 2, Appendix C) 47 FR 9987 (March 9, 1982) were properly applied. We have also given careful consideration to your request for mitigation of the proposed penalties and have concluded that no adequate reasons have been stated as to why the penalties should be reduced or mitigated. Accordingly, we hereby serve the enclosed Order on Sacramento Municipal Utility District, imposing civil penalties in the amount of One-Hundred-Twenty Thousand Dollars.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosure, and your letters will be placed in the NRC's Public Document Room.
