
Attached are changes revising the basis for Technical Specification 3.8 Electrical Power Systems for ANO-2. This change clarifies the Emergency Diesel Generator trips to avoid misinterpretation of the specification. This change is consistent with the requirements of Regulatory Guide 1.108 "Periodic Testing of Diesel Generator Units Used as Onsite Electrical Power Systems at Nuclear Power Plants", Revision 1, August 1977.

We request that this change be issued with the next scheduled amendment. We are planning to implement this change during the 2R8 Refueling Outage.

As this is a change to the Basis of the Technical Specifications, a "No Significant Hazards Determination" is not required. A review of this change in accordance with 10CFR50.59 has concluded that an unreviewed safety question is not involved as a result of this change.

Note that on October 9, 1990, Entergy submitted a Technical Specification Change Request (2CAN109006) to revise Section 3/4.8.1, "A.C. Sources" and the Basis for that section. When this submittal is approved, please incorporate this change in it.
