DECLARATION OF MARK HAIM


I, Mark Haim, declare as follows:

1. In the latter part of July, 1990, I was requested to contact Erman Call, to confirm what he had told Henry Ottinger respecting procedures of the Columbia Fire Department in responding to a fire at MURR. I telephoned Mr. Call, and spoke to him about July 25.

2. In that telephone conversation, Mr. Call told me that, in the event of a fire at MURR, the Fire Department would respond. He stated that, if radioactive materials are burning, "the procedure is not to fight the fire." There is no possibility of my misunderstanding this statement. This seemed to me to be very important, because it was the same thing that he had told Mr. Ottinger, and I gave it very close attention.

3. On December 13, 1990, I visited the Central Office of the Columbia Fire Department. That office has a copy of NFPA 801 (1986) and a copy of NFPA 802 (1988). However, Fire Marshal F. W. Barfield told me that copies of these publications are not made available to the individual fire stations, because they are too expensive. He further stated that, in the event of a fire at MURR, any of the fire stations might respond, and the choice would depend on what other calls the various stations might be responding to at the time.

I declare under penalty of perjury that the above is true and correct.
