SUBJECT: CRGR MEETING NO. 198

The Committee to Review Generic Requirements (CRGR) will meet in the afternoon on Wednesday January 23, 1991, in Room 6507, MNBB. The agenda is as follows:

- 1:00-2:00 p.m. The CRGR will discuss a draft presentation for a Commission meeting on CRGR activities (which is currently scheduled for February 25, 1991). The CRGR staff expects to provide a proposed outline by January 18, 1991.
- 2:00-4:00 p.m. L. Shao (RES) will present for CRGR review a final amendment to 10 CFR 50 Appendix J on containment leakage testing and an associated draft regulatory guide. The review package will be distributed to CRGR members by January 11, 1991. The CRGR staff expects to provide an issue sheet by January 18, 1990.
- 4:00-4:30 p.m. D. Ross (AEOD) will provide a briefing on current activities related to implementation of the safety goals.
- 4:30-4:45 p.m. The CRGR will briefly discuss the question of whether the regular meeting times should be changed, e.g., from Wednesday afternoons to Tuesday mornings.
- 4:45-5:00 p.m. The CRGR will briefly discuss planning and agenda matters for future meetings. The CRGR staff will provide a status report by January 18, 1991.

This will include a discussion of whether the SER on removing the steam line radiation automatic scram for BWR's should be handled as a negative consent matter. (The review package was sent to CRGR members on 12/31/90.)

If a CRGR member cannot attend the meeting, it is responsibility to assure that an alternate, who is approved by the CRGR Chairman, attends the meeting.

Persons making presentations to the CRGR are responsible for (1) assuring that the information required for CRGR review is provided to the Committee (CRGR Chapter - IV.B), (2) coordinating and presenting views of other offices, (3) as appropriate, assuring that other offices are represented during the

presentation, and (4) assuring that agenda modifications are coordinated with the CRGR contact (J. Conran x29855) and others involved with the presentation. Division Directors or higher management should attend meetings addressing agenda items under their purview.

In accordance with the EDO's March 29, 1984 memorandum to the Commission concerning "Forwarding of CRGR Documents to the Public Document Room (PDR)," the review packages for items scheduled at th' meeting, which contain predecisional information, will not be released to the PDR until the NRC has considered (in a public forum) or decided the matter addressed by the information.




