IN RESPONSE REFER TO FOIA-90-A-20 (FOIA-20-91)

Dear Ms. Katz:

This is in response to your letter dated April 12, 1990, in which you appealed Mr. Donnie H. Grimsley's response dated April 5, 1990. Mr. Grimsley's response denied the Office of Investigations' (OI) Report of Investigation No. 2-85-031 and its exhibits which were subject to your Freedom of Information Act (FOIA) request for these records.

Acting on your appeal, I have carefully reviewed the record in this case and have determined that since an enforcement action, including a proposed civil penalty, was issued on April 12, 1990, most of the OI report and its exhibits can now be made publicly available. Your appeal is, therefore, partially granted and partially denied.

Exhibits 7, 8, 9, 10, 11, 12, 14, 18, 19, 20, 21, 22, 23, 26, 28, 31, 36, 41, 44, 45, 48, and 57 can now be made publicly available and are enclosed. The disclosable portions of the report and exhibits 2, 6, 17, 25, 29, 30, 38, 39, 40, 42, 43, and 55 are also enclosed.

The remaining portions of the report and exhibits 2, 6, 17, 25, 29, 30, 38, 39, 40, 42, 43 and 55 will continue to be withheld from public disclosure pursuant to Exemptions (6), (7)(C), and (7)(D) of the FOIA (5 U.S.C. 552(b)(6), (7)(C), & (7)(D)) and 10 CFR 9.17(a)(6), (7)(iii), and (7)(iv) of the Commission's regulations.

The information withheld pursuant to Exemptions (6) and (7)(C) consists of the names of individuals whose employment was terminated by the utility, and other personal information the disclosure of which would cause a clearly unwarranted invasion of personal privacy. I find that there are overriding privacy and public interests in protecting this information. The interest in disclosing the information does not outweigh the significant privacy interests of the individuals who, if their identities were disclosed, could reasonably be expected to be subjected to harassment or other harm.

Information withheld pursuant to Exemption (7)(D) consists of the name of a person granted confidentiality by the staff. I am unable to identify any legitimate public interest in disclosing this information.

Exhibits 1, 13, 15, 16, 24, 27, 32, 33, 34, 35, 37, 46, 54, and 56 were originated by the Tennessee Valley Authority and have been referred to TVA for review and direct response to you. Exhibits 3, 4, 5, 47, 49, 50, 51, 5°, and 53 were originated by the Department of Labor and have been forwarded to that agency for review and direct response to you.

This is a final agency action except on the exhibits referred to TVA. As set forth in the FOIA (5 U.S.C. 552(a)(4)(B)), judicial review of this decision is available in a district court of the United States in the district in which you reside or have your principal place of business or in the District of Columbia.
