Subject: Enforcement Conference NRC Report No. 50-410/82-13

This refers to the meeting held at our request at the NRC Region I Office, King of Prussia, Pennsylvania, on October 20, 1982, relating to activities authorized by NRC License No. CPPR-112. This meeting was attended by Mr. W. J. Donlon, yourself, and other members of your staff and by Mr. Ronald C. Haynes, myself and other members of the NRC staff. The subjects discussed at this meeting are included in the NRC Enforcement Conference Report No. 50-410/82-13, which is enclosed with this letter.

It is our view that the meeting was beneficial. It provided you an opportunity to discuss with us your position and corrective actions and improved your understanding of our concerns. Upon completion of your re-inspection of the affected work and our subsequent review of all the findings, appropriate enforcement action will be considered and addressed under separate correspondence.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
