Subject: Inspection Report No. 50-213/90-16

Enclosed is the report of the inspection conducted by Mr. Leonard Cheung of this office from October 1 to October 5, 1990, and subsequent staff review through December 14, 1990, of activities at the Haddam Neck Plant in Haddam, Connecticut. These activities are authorized by NRC Operating License No. DPR-61. Discussions of our findings were held by Mr. Cheung with Mr. F. Sears and other members of your staff on October 5, 1990 and with your Messrs. P. Blasioli and C. Perkins in subsequent telephone conversations on November 13, 1990 and on December 14, 1990.

Specific areas examined during this inspection included your compliance with the orders issued to implement Regulatory Guide 1.97 and are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that some areas of your activities were not conducted in full compliance with NRC requirements as set forth in the Notice of Violation and the Notice of Deviation, enclosed herewith as Appendices A and B, respectively. The violation has been categorized by severity level in accordance with the General Statement of Policy and Procedure for NRC Enforcement Actions, 10 CFR Part 2. Appendix C. You are required to respond to these Notices of Violation and Deviation and in preparing your response, you should follow the instructions in Appendices A and B.

Your cooperation with us in this matter is appreciated.
