This refers to the routine, announced, safety inspection of your annual, emergency preparedness exercise authorized by License Nos. DPR-61, DPR-65, and NPF-49 by a team of NRC inspectors on December 4-6, 1990 at your Millstone Nuclear Power Station, Waterford, Connecticut and to discussions of these findings by Mr. Amato with you and your staff at the conclusion of the inspection.




