## MEETING SUMMARY

SUBJECT: TEMPORARY SUSPENSION OF LICENSED ACTIVITIES

On August 23, 1982, representatives of Radiodiagnostic Imaging Affiliates of Virginia, Inc., (RIA) met with NRC personnel in Atlanta, Georgia, to discuss remedial actions to permit the resumption of licensed activities at a nuclear pharmacy and three area hospitals. This meeting was held at the request of the licensee and the attendance list is attached as Appendix A to this Summary.

RIA of Virginia representatives discussed financial and organizational startup problems that contributed to numerous violations of NRC license conditions and regulations observed during a routine inspection by a Region II representative on August 12, 1982.

The licensee stated that his conduct was not willful, but due to embezzlement and neglect by a key employee. An Order to Show Cause and Order Modifying the License was issued on August 27, 1982, by the Director, Office of Inspection and Enforcement.
