Dear Mr. Vandewalle:

This is to acknowledge receipt of Mr. David Hoffman's letter dated November 6, 1981, which transmitted Revision 5 to the Nuclear Power Plant Security Plans for the Big Rock Point and Palisades plants.

With one exception, we agree that the changes made in these revisions are consistent with the provisions of 10 CFR 50.54(p) and do not decrease the effectiveness of the plans. Our comments concerning those sections of Revision 5 to each plan which will require additional information prior to our acceptance is enclosed. Until such time that Revision 5 is amended, Revision 4 to each security plan will be considered to be the acceptable plan for those sections identified in the enclosed comment. It is requested that you provide your response to our comment within 30 days from receipt of this letter.

Note that the enclosure to this letter and the enclosures to your November 6, 1981 letter contains Safeguards Information and are required to be kept from public disclosure pursuant to 10 CFR 73.21.

The reporting and/or recordkeeping requirements in this letter affect fewer than ten respondents; therefore, OMB clearance is not required under P.L. 96-511.
