Pursuant to the Freedom of Information Act ("FOIA"), 5 U.S.C. §552, request is hereby made on you to produce for inspection and copying all agency records within the possession, custody, or control of the Nuclear Regulatory Commission as custodian for the records of the Atomic Energy Commission ("AEC"), as specifically described below.

In general this FOIA request seeks agency records pertaining to AEC's licensing of Union Carbide Corporation¹ to mine uranium oxide in or around the areas of Uravan, Rifle and Maybell, Colorado, between the years 1946 and 1975. Within this general range of documents, this request specifically seeks the following categories of records:

- a. All licenses to operate, mine, produce or manufacture uranium, uranium oxide, or other radioactive material, issued by AEC to Union Carbide Corporation or its subsidiaries or divisions.
- b. All applications for licenses to AEC from Union Carbide Corporation or its subsidiaries or divisions.
- c. All correspondence between AEC and Union Carbide Corporation or its subsidiaries or divisions.
- d. All records of AEC inspections to Union Carbide Corporation's Uravan, Rifle and Maybell, Colorado, uranium mining facilities.
- e. All records of non-compliance and/or deficiencies with AEC regulations by Union Carbide Corporation or its subsidiaries at its Uravan, Rifle and Maybell, Colorado, uranium mining facilities.
- f. All records reflecting modification, suspension or revocation of any license issued by AEC to Union Carbide Corporation or its subsidiaries or divisions.
- g. All radiation survey programs presented to AEC by Union Carbide Corporation or its subsidiaries or divisions.
- h. All records relating to any pre-licensing visits made by AEC or its agents to the Uravan, Rifle and Maybell, Colorado, uranium mining facilities.
- i. All records relating to the proposed and actual methods by which Union Carbide Corporation and its subsidiaries proposed to deal with liquid and solid waste emanating from its Uravan, Rifle and Maybell, Colorado, uranium mining facilities, and the means of preventing or controlling release of such wastes to unrestricted areas.

- k. All records relating to AEC's inspection of the waste retention systems at Union Carbide Corporation and its subsidiaries' and divisions' Uravan, Rifle and Maybell, Colorado, uranium mining facilities.
- All records relating to the modification of any license issued by AEC to Union Carbide Corporation or its subsidences or divisions to permit the discharge or release of radioactivity in higher concentrations than allowed by then applicable AEC rules and/or regulations or other applicable rules and/or regulations.

- All records relating to findings of deficiencies as a result of annual inspections referred to above in subparagraph (n).
- p. All other records not specifically covered in subparagraphs (a)-(o) relating to the licensing and operation of the Union Carbide Corporation's uranium mining facilities of Uravan, Rifle and Maybell, Colorado, during the years 1946 to 1970.

2. All contracts between the United States Government and Union Carbide Corporation or its subsidiaries or divisions relating to the mining, manufacture, production, or sale of uranium and uranium oxide.

3. All records pertaining to the transportation of uranium or uranium oxide between Uravan, Rifle and Maybell, Colorado and Oak Ridge, Tennessee between 1946 and 1974. Nuclear Regulatory Commission August 16, 1990 Page 4

4. All records pertaining to AEC investigations of uranium, uranium oxide, radium, or other radioactive material spills, leaks, discharges, or any other release (including but not limited to releases caused by fire and\or explosions), on site at Union Carbide Corporation or its subsidiaries' facilities at Uravan, Rifle and Maybell, Colorado, or Oak Ridge, Tennessee, between 1946 and 1975.

5. All records pertaining to AEC investigations of radiation exposure or radiation leaks at a site operated by Union Carbide Corporation or its subsidiaries' or divisions' facilities at Uravan, Rifle and Maybell, Colorado, or Oak Ridge, Tennessee, between 1946 and 1975.

6. All reports regarding Union Carbide Corporation or its subsidiaries or divisions.

7. All records reflecting any administrative proceedings or litigation between AEC and Union Carbide Corporation or its subsidiaries or divisions, including all records reflecting any fines or penalties imposed upon Union Carbide Corporation or its subsidiaries or divisions.

8. All records reflecting AEC's knowledge of environmental pollution as a result of water contamination by uranium manufacture waste products in the Uravan, Rifle and Maybell, Colorado, area.

9. All records reflecting AEC's knowledge or opinion of the environmental hazards posed by existing, uncovered or unstabilized tailings piles in the Colorado River Basin between the years 1946 and 1975.

10. All records reflecting AEC's knowledge or opinion of the environmental hazards posed by seepage, leaks or releases from ponds used to contain or store waste created by uranium mining in the Colorado River Basin.

11. All transcripts or minutes of hearings or meetings between AEC and representatives of Union Carbide Corporation or its subsidiaries and divisions.

12. All correspondence by third parties to AEC concerning the uranium mining activities of Union Carbide Corporation or its subsidiaries or divisions.
