A routine radiological controls inspection was conducted by Mr. R. L. Nimitz at the Maine Yankee Power Station on December 10-14, 1990, and a special reactive radiological controls inspection was conducted during the period December 21-22, 1990. Areas reviewed during the routine inspection included licensee action on previous inspection findings, organization and staffing, audits, radiological controls program improvement initiatives, control element assembly (CEA) cutting, and contamination controls. The special reactive inspection reviewed the adequacy and implementation of enhanced radiological controls for the primary to secondary steam generator tube leak and radiological controls for inspection and repair of the tube. The routine inspection findings were discussed with you on December 14, 1990, and the results of the special reactive inspection were discussed with Mr. R. Blackmore on December 22, 1990.

No violations were identified. The inspection indicated that your staff effectively responded to the increased primary to secondary leakage and implemented appropriate radiological controls for the secondary side of the station. Station staff appeared to be performing good planning for the cutting and shipping of the CEA sections. Weaknesses were identified in the exposure control program, the training of contractor radiological controls personnel and High Radiation Area access controls. Your staff took immediate actions to address the weaknesses. The weaknesses and several areas for improvement are discussed in the enclosed report.

No response to this report is required. Your cooperation with us is appreciated.
