Thank you for accommodating NuScale's input at the meeting today. To ensure the transcript captures our input correctly – here is what we stated on the phone.

"NuScale does not manufacture the fuel for our Small Modular Reactors (SMR). Plant owners – our customers – typically manage contracting for fresh fuel and spent fuel handling. Potential NuScale customers in foreign nations have expressed interest in a U.S. fuel takeback option that involves reprocessing. Such an option is particularly attractive to those customers in smaller nations with an intention to have limited nuclear deployment, but are reluctant to move forward, because it is generally impractical or technically infeasible to develop a long-term national spent fuel disposition program for such limited deployment."
