J. T. Yerokun and D. Casada at the Maine Yankee Atomic Power Station, Wiscassett, Maine. The results of this inspection, as detailed in the enclosed report, were discussed with Mr. R. Prouty and other members of your staff at the conclusion of the inspection by Massrs. Yerokun and Casada. The inspection focused on your activities for NRC Bulletin 88-04, Potential Safety Related Pump Loss. Within this area, the inspection consisted of selected examinations of procedures and representative records, interviews with personnel, and observations by the inspector. Within the scope of this inspection, no violations were observed. The inspectors observed that engineering evaluation and documentation for those systems addressed by the bulletin were generally good. However certain issues (Adequacy of the high pressure safety injection see em operation during fill and vent mode and alternate letdown mode - Section 2; Adequacy of a common six inch discharge line for all containment spray and low pressure safety injection pumps during minimum flow operation - Section 3; Discrepancy between actual and stated flow rate in the licensee letter for the containment pray s, stem surveillance - Section 4 and Adequacy of 20 gpm flow rate for the emergency feed water system surveillance tests - Section 5) require resolution as discussed in this report. Your staff agreed to resolve these issues by March 15, 1991. If our understanding of this agreement is not accurate, please notify me as soon as possible. 230002
