Subj: Unit 2 Contractor/Vendor Photo-Identification Re-badging; promulgation of schedule and general instructions pertaining to

1. Effective 0700 Monday 19 November 1979, photo-identification re-badging of all contractor/vendor personnel authorized Unit 2 access will commence. The following general instructions will apply:
 - a. Initially, all badging will be accomplished daily (Monday thru Friday) between the hours of 0700-1700 within the gray security processing trailer immediately south of the TLD-issue Building, adjacent to the Brass Gates, Unit 2.
 - b. Currently-utilized orange and white photo-identification badges will be acceptable for use until 2400 30 November 1979, at which time the new brown and yellow badges will be the only authorized badges for contractor/vendor utilization within Unit 2. (Orange and white badges will continue to be used by those personnel authorized Unit 1 access; but will only be utilized within Unit 1.)
 - (1) For those contractor/vendor personnel having access to both units, two (2) sets of badges must be utilized; dependent upon the Unit within which the individuals are currently working will determine which set to be utilized.
 - (2) As white badges are currently utilized to allow access to the Owner-Controlled Area(s), yellow badges will be used within Unit 2 for that purpose. The yellow badge will then be exchanged at the entrance(s) to the Unit 2 Protected Area for the brown photo-identification badge, which denotes authorization to enter the Protected/Vital Areas.
 - (3) Accordingly, it will be necessary for those personnel having both Unit 1 & 2 access to carry both their white and yellow badges with them, when reporting for work, so as not to cause undue delays in processing and verifying access authorizations required to enter TMI, either from the North or South Gates. (Yellow badges will allow an individual to enter the South Gate and white badges will utilize the North Gate for work assignments.)
2. In accordance with the time schedule denoted above, System personnel having Unit 2 access will have a "2" affixed to their current System ID badge and green photo-identification badge.
 - a. The absence of the affixed "2" to either badge will denote access "Not Authorized" for Unit 2.

3. For all personnel, both System and contractor/vendor personnel, having access to Unit 2 Owner-Controlled Area only, the numeral "0" will be affixed to either the System badge (for System personnel) or the yellow photo-identification badge (for contractor/vendor personnel). This action will assist the Site Protection Officers in determining access authorization to the Protected/Vital Areas for authorized personnel only.
