During the meeting held in your offices on September 30, 1982, Illinois Power Company indicated that the Clinton Power Station Overinspection Program Plan would be prepared by November 1, 1982.

In order to obtain an independent technical review which will provide increased engineering assurance and more compatibility with the document verification program, outside assistance is being sought. This additional review of the plan will include comparison to industry practices for product and documentation acceptance through sampling methods.
