Under the Freedom of Information Act I request copies of the following documents:

1. All U.S.-origin publications, files, correspondence, or other documents, containing analyses, discussions, or presentations of:
  - Canadian-source emissions of radioactive materials into the Great Lakes, or other bodies of air or water of concern to U.S. interests;
  - Comparisons of such emissions and U.S.-source emissions; or
  - Comparisons of Canadian and U.S. regulations governing radioactive emissions; and
2. A list of all U.S.-origin publications, files, correspondence, or other documents, containing analyses, discussions, or presentations of:
  - Canadian-source emissions of non-radioactive toxic materials into the Great Lakes, or other bodies of air or water of concern to U.S. interests;
  - Comparisons of such emissions and U.S.-source emissions; or
  - Comparisons of Canadian and U.S. regulations governing such emissions.

Please reply within 10 working days by international air mail.

My organization is a non-profit citizens' group. We shall use the documents to educate the public and to seek reform in government policies. Therefore we request a waiver of search and copying fees.

I have also contacted E.P.A. with a very similar request. It is not my intention to request or receive duplicate information.
