Dear Mr. Grimsley:

This is a request under the Freedom of Information Act as amended (5 USC Section 552).

I wish to obtain copies of all correspondence and communications between Rep. H. James Saxton or his congressional staff and your agency. Also, I wish to obtain copies of any other writings which reflect to Rep. Saxton or to matters relating to New Jersey's Thirteenth Congressional District.

In order to assist you with your search, I offer the following information: H. James Saxton was sworn into office as a United States Representative for New Jersey's Thirteenth Congressional District in January, 1985 and continues to serve as the representative for that district. As a representative, Rep. Saxton has served on the following committees or subcommittees:

Banking, Finance and Urban Affairs. Subcommittees: Consumer Affairs and Coinage; Financial Institutions Supervision, Regulation and Insurance; Housing and Community Development; International Development, Finance, Trade and Monetary Policy.

Government Operations. Subcommittees: Commerce, Consumer, and Monetary Affairs; Legislation and National Security.

Merchant Marine and Fisheries. Subcommittees: Fisheries and Wildlife Conservation and the Environment; Merchant Marine; Oceanography, Oversight and Investigations.

Select Committee on Aging. Subcommittees: Human Services; Retirement Income and Employment, Health and Long-Term Care.

The information I am seeking should include, but not be limited to, correspondence and communications resulting from his committee assignments. Prior to his election to the House of Representatives, Rep. Saxton served as a New Jersey State Senator (1981-1984) and as a New Jersey State Assemblyman (1975-1981).


