BROWNS FERRY NUCLEAR PLANT, UNITS 1, 2 AND 3

- 1. Item II.B.4 of NUREG-0737 requires shift technical advisors and operating personnel from the plant manager through the operations chain to receive the training identified in Enclosure 3 to Denton's letter dated March 28, 1980. (Letter dated March 28, 1980 from Harold R. Denton, USNRC to "All Power Reactor Applicants and Licensees" concerning qualifications of reactor operators.) The TVA response to NRR dated May 6, 1982, does not include the plant superintendent and assistant plant superintendents in the personnel that receive this training. Describe the training program that is provided to the plant superintendent and assistant plant superintendents that covers the subject matter contained in Enclosure 3 to Denton's letter.
- 2. TVA correspondence to NRR dated May 6, 1982, stated in response to Questions 5 and 6 that 32 hours of retraining is provided in the operator requalification program and 16 hours of specific mitigating core damage training. Additionally, TVA stated that the total combined hours of training meet or exceed 80 contact hours. Please clarify this area of apparent conflict; i.e., 48 hours vice 80 hours. In addition, please identify how many hours of training are provided in each area in the initial operator training program.
