This letter transmits the report of the routine resident safety inspection conducted by Ms. A. Asars of this office during the period December 19, 1990 to January 29, 1990 at the Haddam Neck Plant, Haddam Neck, Connecticut. The report covers activities authorized by NRC License No. DPR-61. The inspection findings were discussed by Ms. Asars with Messrs. Bouchard and Ray of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel and observations by the inspectors.
