Dear Mr. Starostecki:

The referenced inspection response addressing Item 'B' stated that "the present controls are adequate to preclude violations." The Power Authority has further reviewed the subject violation and has found that the present controls were not adequate. A formal procedure for key control was approved and implemented on October 19, 1982. This procedure requires a sign-in and sign-out for these keys, a review by the Shift Supervisor on a shift basis and a periodic inventory of the keys involved.

The referenced inspection response for Item 'C' stated that a periodic cleaning program would be initiated, on a trial basis, by August 31, 1982. The Maintenance Department recently changed superintendents and the new superintendent is in the process of reviewing this program. The program will start trial implementation on December 1, 1982.
