

## Description of Event

The delivery of new fuel assemblies, scheduled for December 11, 1985, was unaccounted for after the estimated arrival time of 0700 hours.

In accordance with our procedures, the Nuclear Fuel Manufacturing Department, General Electric Company was notified at 0703 hours by security officer L. W. Miles. In turn, the Assistant Supervisor, Nuclear Security; the Supervisor, Nuclear Security; and the Assistant Supervisor, Operations were notified at 0705 hours, 0706 hours and 0729 hours respectively.

Although it was the responsibility of the NFMD, General Electric Company, per written agreement, to implement 10 CFR 73.67(g)(3), it was deemed prudent to advise the NRC Operations Center of the event. Mr. C.U. Dann, the Duty Offier was advised at 0729 hours.

Finally, the Oswego County Sheriff's Department was advised at 0732 hours.

At 0755 hours, the Station Superintendent's office was contacted by the transport driver. The vehicle was thirty miles south of the New York border, in Pennsylvania. It had been delayed by inclement weather.

All individuals and agencies previously notified were updated. The shipment arrived at 1039 hours and General Electric Company was notified.
