Dear Mr. Pelizza:

Our office is in receipt of your October 31, 1990, amendment request discussing decommissioning progress and license conditions which no longer have applicability. License Condition Nos. 13, 17, and 18 are specific to the evaporation ponds. Because the ponds have been decommissioned and are appropriately decontaminated, as rerified in the attached data, the above cited license conditions may be deleted.

It is our understanding that you have also requested that License Condition Nos. 25 and 30 be deleted from your license, discussing 10 CFR 20 posting and weekly security inspections, respectively. The analytical data enclosed with this correspondence as well as data that you have collected indicate that the facility has been decontaminated. However, it is our understanding that contaminated materials are contained in barrels that are stored within the facility. Due to this we are unable to delete the requirements associated with posting and security inspections. Upon removal of the byproduct materials from the site appropriate licensing action may be requested.

Therefore, pursuant to Title 10 of the Code of Federal Regulations, Part 40, and in consideration of your October 31, 1990, correspondence, Source Material License SUA-1400 is hereby amended by revising License Condition Nos. 13, 17, and 18 to read as follows:
