SUBJECT: LICENSING ACTION REVIEW FOR NINE MILE POINT UNIT 2,
CHANGE TO INITIAL STARTUP TEST PROGRAM (TAC NO. 66179)

Region I has completed the Licensing Action Review for a proposed change to the Final Safety Analysis Report representing changes to the startup test program, which was submitted to NRR by licensee letter NMP2 1074 dated September 9, 1987. Based on this evaluation, as documented in the enclosed safety evaluation and SALP Input, the proposed change is found acceptable.

The revised Final Safety Analysis Report changes for Chapter 14 have been enclosed as Enclosure 2. This action completes work performed by Region I under TAC 66179. The principal reviewer was L. Wink of the Division of Reactor Safety.
