Meeting Summary

Meeting on November 3, 1982 (Report Nos. 50-295/82-26(DETP); 50-304/82-23(DETP))
Areas Covered: A meeting was held at the Commonwealth Edison Company's corporate office on November 3, 1982 to discuss the findings and actions requested as a result of the NRC investigation of allegations relating to drug abuse by employees at the site and several other allegations. A total of 24 NRC man-hours was involved in the meeting.

2. Management Meeting: The meeting was scheduled at the request of Region III in order to provide the licensee's management the final results of the investigation conducted at the Zion facility during the period December 23, 1981 through June 15, 1982. The investigation was conducted as a result of several allegations concerning the use of drugs and drug related operational problems, the conduct of the licensee's management during their own investigation into drug use and other allegations relating to the conduct of plant employees and security guards.

The detailed description of the investigation is documented in a report (Report Nos. 50-295/81-32(DETP); 50-304/81-30(DETP)) which was presented to the licensee during this meeting. The actions which we requested the licensee to take as a result of our findings are detailed in Appendix B to the November 2, 1982 letter which transmits the report to the licensee.

- a. The Regional Administrator opened the meeting by discussing its purpose and conduct. He explained that in order to fulfill an earlier commitment made by Region III, appropriate law enforcement authorities would be briefed immediately following this meeting.

In order that all those present understood the perspective of the report, findings, and requested actions, the Regional Administrator provided a brief summary of the background and conduct of the investigation.

- b. The briefing was then continued by the Director, Division of Emergency Preparedness and Operational Support. His presentation included a discussion (by means of projected slides) of the allegations, which are delineated in the report, and a short synopsis of relevant background information pertaining to each allegation. The "Conclusion" for each allegation was read from the body of the report. Licensee questions were answered as they were asked.
- c. The briefing concluded with a presentation of the "Findings" and "Requested Actions" described in Appendix B to our November 2, 1982 transmittal letter. Each of the ten findings and requested actions was also summarized by projected slides. The contents of Appendix B were read for the benefit of those present. The licensee's management representatives acknowledged each of the matters discussed and indicated that they would be addressed in writing.
