This purposes of this modification is to: 1) increase the total amount of contract by \$8,192.00, 2) revise course scheduling in include the fourth course, and 3) extend the period of performance for one additional year. Therefore, the contract is modified as follows:

1. a. Section 8.2 is revised to read as follows:

Total Price.....\$81,664.00

- b. SF26, Block 15G, Total Amount of Contract, is revised to read, "81,664.00".

2. Delete Section F.1.2, Number of Courses/Course Scheduling as shown and replace with the following:

"F.1.2 Number of Courses/Course Scheduling

- (a) The initial course is scheduled to begin August 17, through August 21, 1987. Up to five (5) courses may be presented under this contract.
  - (b) The second course is scheduled for July 10, through July 14, 1989.
  - (c) The third course is scheduled for June 11, through June 15, 1990.
  - (d) The fourth course is scheduled for March 4, through March 8, 1991. Exact course dates for the remaining course will be arranged with the contractor."

3. Section F.3, Duration of Contract Period, is revised to read as follows:

"This contract shall become effective on March 3, 1987 and shall continue through March 29, 1992.

All other terms and conditions remain the same.
