

Subject: Combined Inspection 50-277/82-21, 50-278/82-20

This transmits the findings of the routine resident safety inspection by Mr. A. R. Blough on September 16 - October 20, 1982 at the Peach Bottom Atomic Power Station, Delta, Pennsylvania. These findings were based on observation of activities, interviews, and document reviews, and have been discussed with Mr. W. T. Ullrich of your staff.

Apparent violations of NRC requirements are cited in Appendix A and categorized in accordance with 10CFR2 Appendix C and Federal Register Notice 47FR9987 (March 9, 1982). A reply is required and should be prepared in accordance with Appendix A. It is exempt from the Office of Management and Budget's clearance procedures under the Paperwork Reduction Act of 1980, PL 96-511. Your reply need not address Item A.3, which was corrected during the inspection. Item A.2 is a recurrent violation and should therefore receive particular attention.

Page 15 of the enclosed report contains physical security information which will be disclosed only in accordance with 10CFR9.12. In accordance with 10CFR2.790(a), a copy of the rest of this transmittal will be placed in the NRC Public Document Room, unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of this letter. Such application must be consistent with the requirements of 10CFR2.790(b)(1).
