
Subject: Inspection 50-320/82-11

This refers to the routine safety inspection conducted by Mr. R. Conte of this office on August 8 - September 11, 1982, of activities authorized by NRC License DPR-73 and to the discussions of our findings held by Mr. Conte with Mr. J. Hildebrand and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed. However, Details, paragraph 5 of the enclosed inspection report discusses several items requiring your attention which arose from concerns expressed to the NRC on-site staff by utility workers who are assigned to the Unit 2 contamination control corridor. While no violations of NRC requirements were identified, we believe that the actions which you committed to take will further enhance your radiation protection program and worker safety. Please provide our on-site staff with a schedule for implementing your actions.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.



We believe the concerns identified in paragraph 5 of the attached report require your attention. Accordingly, please respond to this letter detailing the action and completion dates for improvements in the areas discussed in paragraph 5.
