Dear Ms. Stein:

This letter confirms agreements reached during telephone conversations on February 15, 1991, between Messrs. John A. Grobe and John R. Madera of my staff and you regarding temporary relaxation of our Confirmatory Action Letter (CAL) dated September 25, 1990 as modified on October 16 and 19, 1990. Because of the resignation of your Radiation Safety Officer (RSO), that CAL confirmed your commitment to suspend operations under License No. 34-19089-01. That CAL was modified on October 16, 1990 and October 19, 1990, to allow resumption of teletherapy service operations and clarify monthly emergency generator battery check procedures. This temporary relaxation of that CAL concerns performance of corrective maintenance on your hot cell ventilation system.

Based on the conversations on February 15, 1991, we understand that corrective maintenance is necessary to replace the hot cell ventilation system fan belts. We understand that corrective maintenance work on that fan will be performed under the direction of Mr. Michael Ginzel. We have reviewed Mr. Ginzel's qualifications as supplied by you in your letter dated December 27, 1990, and we have discussed Mr. Ginzel's plans for this work activity with him. We find Mr. Ginzel's qualifications and plans for this job acceptable. We further understand, in accordance with your faxed message dated October 10, 1990, Mr. Steve McDermott, your former RSO, will be available to assist Mr. Ginzel in response to any radiological emergencies that may occur at the London Road facility. Should this corrective maintenance be delayed beyond February 15, 1991, we understand that daily checks will be made to assure negative pressure is maintained in the hot cell and air quality around the hot cell remains acceptable.

Consequently, Item 1 of the CAL dated September 25, 1990 is relaxed to allow performance of the hot cell ventilation system corrective maintenance.
