The Committee to Review Generic Requirements will meet on Wednesday, December 8, 1982, from 1-4 p.m. in Room 6507 MNBB.

1:00-2:00 p.m. K. Goller (RES) will brief the Committee concerning the proposed Regulatory Guide (IC 126-5), "Instrument Sensing Lines." RES has not forwarded the RG for CRGR review because the staff believes that the RG does not promulgate any positions that have not previously been provided.

2:00-4:00 p.m. M. Ernst (NRR) will present for Committee review the proposed NRR Staff Implementation Plan For The Commission's Safety Goal. NRR will forward the Plan to the Committee by December 1, 1982.

Persons making presentations to the CRGR are responsible for (1) assuring that the information required for CRGR review is provided to the Committee (CRGR Charter - IV.B), (2) coordinating and presenting views of other offices, (3) as appropriate, assuring that other offices are represented during the presentation, and (4) assuring that agenda modifications are coordinated with the CRGR contact (Walt Schwink, x24342) and others involved with the presentation. With regard to attendance at CRGR meetings, I request that Office Directors limit attendance of their staffs at CRGR
