TWO RIVERS (AP) - Wisconsin Electric Power Co. said Thursday one of the two generalors at its Two River nuclear-fuel power plant will be title for several days because of a radioactive leak.

The company said the No. 2 reac-The company said the No. 2 reactor at the plant beside Lake Michagan would be out of service Friday through Wednesday for repair of a leak that allowed a small amount of contaminated water to escape.

Lauretta Krehma-Olson, plant coordinator, said radioactive water was escaping at a rate of less than a sallon a minute.

"It's not an emergency. It's a shutdown to repair a piece of equipment," she said.

It was discovered two weeks ago, she said. The radioactive water is being captured in a containment building and "no radioactivity has been raleased outside the plant,"

she said.
"It's a minor leak," said Russ Marabito, a spokesman for the U.S. Nuclear Regulatory Commission's office in Glen Elyn, III.
The NRC allows a plant to operate until a leak reaches 25 gallons a

minute, Marabito said.
