This refers to the inspection conducted by Mr. J. T. Conway of this office on August 16-20, 1982, of your facility at Cicero, Illinois, associated with the manufacture of nuclear flanges and to the discussions of our findings with Mr. E. J. Razim at the conclusion of the inspection.

This inspection was made as a result of the 10 CFR Part 50.55(e) notification reported by Pennsylvania Power & Light Company relating to inadequate thickness of main steam relief valve discharge line flanges furnished to the Susquehanna Steam Electric Station.

Areas examined and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

During the inspection it was found that the implementation of your QA program failed to meet certain NRC requirements. The specific findings and references to the pertinent requirements are identified in the enclosures to this letter.

Please provide us within 30 days from the date of this letter a written statement containing: (1) a description of steps that have been or will be taken to correct these items; (2) a description of steps that have been or will be taken to prevent recurrence; and (3) the date your corrective actions and preventive measures were or will be completed. Consideration may be given to extending your response time for a good cause shown.

The response requested by this letter is not subject to the clearance plocedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
