In our letter to you on December 14, 1990 listing our corrective action, we stated that all licensed material would be transferred from the Valentec Product Development Center to the Valentec Olivette facility by December 21, 1990.

The licensed material used at the Product Development Center is classified by the Department of Defense. Due to delays imposed by the Defense Investigation Service in getting our DU storage vault cleared for classified material, we will have to postpone the transfer and application for termination of the Product Development Center license until approximately January 20, 1990.

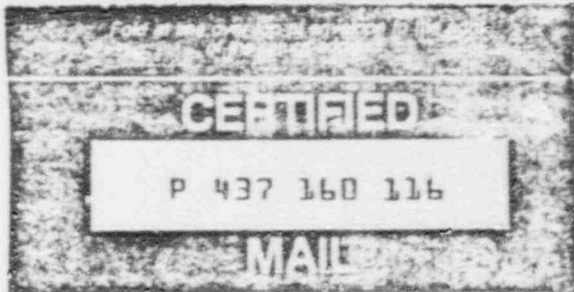
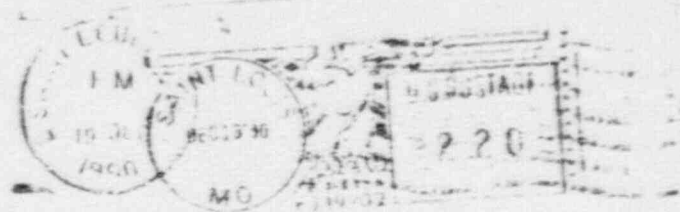

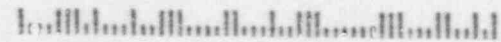
