NRC Regulatory Issue Summary 2020-01
Preparation and Scheduling of Operator Licensing Examinations

On February 19, 2020, NRC issued Regulatory Issue Summary (RIS) 2020-01, *Preparation and Scheduling of Operator Licensing Examinations*. RIS 2020-01 requests licensees to submit, on a voluntary basis, information pertaining to their proposed site-specific operator licensing examination schedules and the estimated number of applicants planning to take operator licensing examinations, as well as whether the licensee or the NRC will prepare the examinations. The NRC stated that this information would help the NRC to more effectively utilize its resources. A response was requested within 30 days of receipt of RIS 2020-01.
