The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2019-013) on August 29, 2019, to determine whether a senior reactor operator (SRO) deliberately performed duties while under the influence of alcohol. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the SRO deliberately performed duties while under the influence of alcohol.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
