BRIEF

- 1. The NRC Staff has filed a Motion for Summary Disposition on the Quality Assurance Contention. The response to this Motion is due on November 23. 1982.
- 2. At a recent conference call, the undersigned did state that he would make every effort to file Sunflower's response within the 20 day period provided by the Commission's Rules. However, the undersigned cannot.
- 3. The reason for this request for additional time is the fact that due to the press of other business the undersigned has not had the opportunity to research the Commission's cases, Rules and Regulatory Guides on the issue of Quality Assurance. The local law library does have the CCH service on NRC cases but some of these cases are missing. The University of Akron Law Library does have the recent issuances issued by the Commission but it is located in Akron, Ohio. Since the November 10th conference call, the undersigned has been involved with a housing discrimination charge filed by HUD; has been involved with a matter with the U.S. Bankruptcy Court and has been out of town for two days.
