This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by Ms. C. Connell, Mr. H. Bermudez, Mr. J. Ennis, and Mr. L. Franklin on June 17-21, 1991, at your university's Medical Sciences Campus, Rio Piedras Campus, Agricultural Experiment Station and Mayaguez Campus. At the conclusion of the inspection, the findings were discussed with you.

The inspection was an examination of activities conducted under your license with respect to radiation safety and compliance with NRC regulations and the conditions of your license. It included selective examinations of procedures and representative records, interviews with personnel, and direct observations by the inspectors.

The inspection findings indicate that certain activities appeared to violate NRC requirements. The apparent violations described in the enclosed report are under consideration for escalated enforcement action. Accordingly, no Notice of Violation is being issued at this time. However, please be advised the number and the character of the apparent violations described in the enclosed inspection report may change as the result of further NRC review. An Enforcement Conference to discuss these violations has been scheduled for July 26, 1991. Arrangements for this Conference were confirmed by separate correspondence. You will be advised by separate correspondence of the results of our deliberations on this matter.
