SUBJECT: CONFIRMATION OF ENFORCEMENT CONFERENCE ARRANGEMENTS

This confirms the arrangements made between Ms. Marilu Morales, Secretary of the President, and Mr. Hector Bermudez of this office during a telephone conversation on July 2, 1991, concerning an Enforcement Conference to be held in the Region II office at 9:00 a.m. on Friday, July 26, 1991.

We requested this meeting to discuss apparent violations which were identified during a team assessment of your facilities at the Medical Sciences Campus in San Juan, the Rio Piedras campus in Rio Piedras, the Agricultural Experiment Station in Rio Piedras, and the Mayaguez Campus in Mayaguez conducted on June 17 through June 21, 1991. The apparent violations will be discussed in an NRC Inspection Report which will be forwarded to you at least one week before the meeting. At this Conference you should be prepared to discuss actions you plan to take or have taken as a result of the findings. You should also be prepared to discuss the potential hazards related to the present waste storage areas at the Medical Science Campus. We request that a representative from the Medical Science Campus and the Rio Piedras campus also attend; however, you may bring additional representatives, if you desire. A proposed meeting agenda is enclosed.
