Subject: Modification No. 7 to Task Order No. 006
Under Contract No. NRC-39-89-133

This confirms verbal authorization provided to Mary Doyle, DCCA, from Deborah Boyd, of my staff, on Friday, January 4, 1991, to commence work under the subject task order.

The purpose of this modification is to: (1) authorize overtime support (22 hours x premium rate of \$11.22) in accordance with FAR Clause 52.222-2, Payment for Overtime Premiums (APR 1984), (2) increase the task order ceiling amount, and (3) provide incremental funding in the amount of \$598.48. Accordingly, the following changes are hereby made:

1. Overtime is authorized for data entry operators for the purpose of entering T&A data into the NRC Payroll System. The contractor shall provide two(2) data entry operators to work 8 hours on Saturday, January 5, 1991 at the Maryland National Bank Building and shall provide one(1) data entry operator to work 3 hours on Monday evening, January 7, 1991 and 3 hours on Tuesday evening, January 8, 1991.

Therefore, the total number of hours authorized for overtime under the subject task order to-date are 450 hours.

2. The third paragraph of the definitization letter is revised to read as follows:

"Task Order No. 06 shall be in effect from February 1, 1989 through April 30, 1991 with a total cost ceiling of \$375,404.22. The amount of \$349,125.92 represents the total estimated reimbursable costs and the amount of \$26,278.30 represents the fixed fee."

3. The fourth paragraph, first sentence, of the definitization letter is revised to read as follows:

"The amount presently obligated with respect to this task order is \$375,402.88 of which the amount of \$349,124.38 represents the total reimbursable costs and the amount of \$26,278.20 represents the fixed fee."
