On November 18, 1982 West Valley Agricultural Protection Council, Inc. (West Valley) filed a "§supplemental Memorandum" in support of its petition to intervene which responds to Joint Applicants' and Staff's answers of November 9, 1982 and November 15, 1982, respectively. The NRC Rules of Practice, at 10 C.F.R. § 2.714(a) and 2.730(c), do not allow the filing of a reply by the moving party to another party's answer in circumstances where, as here, the moving party has not received permission to do so. <u>Public Service Company of Oklahoma et al</u>. (Black Fox Station, Units 1 and 2), LBP-76-38, 4 NRC 435, 441 (1976). Specifically, 10 C.F.R. § 2.730(c) states (in pertinent part):

The moving party shall have no right to reply, except as permitted by the presiding officer or the Secretary or the Assistant Secretary."

The NRC Staff, therefore, suggests that the "Supplemental Memorandum" be disregarded.
