\*During a telephone conversation between Ms. Joan Burns and Ms. Nina Pugh of our offices on November 21, 1990, Ms. Pugh informed Ms. Burns that the previously awarded contract, (39-88-230) under Solicitation RS-ARM-89-230, "Advice and Assistance to Micro-computer and Lan Users," is available for public inspection at no charge and copying at a nominal charge at the NRC's Public Document Room (PDR). This contract which is identified on enclosed Appendix A contains the awardee's name, award date, list of specifications or statement of work, terms of the contract, types of service, contract dates, user(s), and the costs of the contract.
