Gentlemen:

We have completed a review of certain applications for license amendments which your Company filed with the Office of Nuclear Reactor Regulation (ONRR) for review for the Maine Yankee Atomic Power Station. The purpose of this review was to determine what fees pursuant to 10 CFR 170.22, if any, are due the USNRC and what refunds might be due your Company for these applications. In this connection, enclosed is a list which shows the application dates, the fact that no fees were paid, fees that are applicable, and ONRR's final fee determination on each of these approved applications.

Based on the ONRR staff's fee determinations, a total of \$13,200 is due the USNRC. Therefore, your Company should remit this amount to our office. Although you stated in your February 13, 1981 application that a check in the amount of \$4,000 was enclosed, this check was not received by us.

We regret the delay in bringing these fee matters to your attention.
