Dear Sir:

The reference 4 telect. and a subsequent review of the related correspondence made me aware that the intent of our letter of January 10, 1991 (Ref. 3) was not adequately communicated. This letter is intended to clarify the information previously provided as well as to acknowledge that the incorrect information reflected in the NRC letter of May 23, 1990 (Ref. 2) was based on information provided by Philadelphia Electric Company (PECo).

U.S. Nuclear Regulatory Committee January 25, 1991 'Attn: Document Control Desk Page 2 In our letter dated February 13, 1989 (Ref. 1), PECo responded to Generic Letter 88-14, "Instrument Air Supply System Problems Affecting Safety-Related Equipment." This response identified several actions to be completed and stated, in part, that "a summary report will be submitted by 60 days following restart from the next refueling outage of Peach Bottom Atomic Power Station, Unit 3..." The Nuclear Regulatory Commission (NRC) response dated May 23, 1990 (ref. 2) stated that a summary report on all actions taken at Peach Bottom and Limerick will be submitted in the Summer of 1991. Information on Peach Bottom outage dates was verbally supplied by us. It appears that the Summer of 1991 date was based on our inadvertent use of the PBAPS Unit 2 rather than Unit 3 outage schedule. Based on the current PBAPS Unit 3 outage schedule, we anticipate that a final response will be submitted in early 1992. The current scheduled end date for the Unit 3 refueling outage is December 6, 1991. To summarize, based on our previous commitment and the current Peach Bottom outage schedule a summary report on actions taken at LGS and Peach Bottom in response to Generic Letter 88-14 will be submitted in early 1992.
