SUBJECT: NRC INSPECTIONS 50-245/93-05, 50-336/93-09, and 50-245/93-20

This refers to three unresolved items 50-245/92-22-01, 50-336/91-28-01, and 50-245/91-01-11 documented in the subject inspection reports that were closed by the NRC during inspections at the Millstone Nuclear Power Station in Waterford, Connecticut. The NRC staff has recently revisited these issues. We determined that these unresolved items included violations of regulatory requirements; however, the violations were evaluated and closed by inspectors without the issuance of a Notice of Violation or the explicit exercise of discretion as described in Section VII.B of the NRC Enforcement Policy.

The NRC is issuing the enclosed Notice of Violation to document the violations of regulatory requirements. However, after considering the facts of these issues, including the low safety/regulatory significance and your corrective actions taken, the NRC has decided not to require a response to the Notice. These findings were discussed with Mr. D. Miller on January 26, 1994.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter will be placed in the NRC's Public Document Room.
