Inspection Summary

Inspection on October 25-29, 1982 (Report No. 50-346/82-30(DETP))
Areas Inspected: Included a review of Security Organization - Management, Personnel, and Response; Records and Reports; Testing and Maintenance; Physical Barriers - Vital Areas and Protected Areas; Access Controls - Personnel, Packages, and Vehicles; Detection Aids - Vital Areas and Protected Areas; Safeguards Contingency Plan; Guard Training and Qualification Plan; Followup on Previous Items of Noncompliance; and Independent Inspection Effort. The inspection involved 74 inspector-hours onsite by two NRC inspectors. The inspection began during the day shift period; 16 of the 74 inspector-hours were accomplished during offshift periods.

Results: The licensee was found to be in compliance with NRC requirements within the areas examined during this inspection except for the following two items:

1. Security Organization - Personnel: A security Officer performed duties without being fully qualified in one aspect of the duty.
(Paragraph 7.a)
2. Access Control - Personnel: Protected area badges on one observed occasion were not issued in accordance with the licensee's procedure.
(Paragraph 13.a)

Two items of noncompliance noted in the previous inspection were closed. All areas of concern noted in the previous inspection were closed. An area of concern pertaining to maintenance support for certain security equipment was noted during this inspection. The licensee's commitments pertaining to the area of concern appeared adequate to resolve the issue.
