This acknowledges the receipt of your letter of November 30, 1990, which transmitted Revision 10 to the McGuire Guard Training and Qualification Plan.

During our review it was noted that several of the changes contradicted statements in the McGuire Physical Security Plan (PSP). Upon contacting Mr. R. Cross of your office on January 16, 1991, Ms. C. Perny of this office was advised that due to some corporate staffing changes the necessary revisions to the McGuire PSP were delayed.

We are now in receipt of the McGuire PSP Revision 42 which addresses those changes which were noted as inconsistencies in the Training and Qualification Plan.

Our review of the changes to the Training and Qualification Plan has found them to be consistent with the provisions of 10 CFR 50.54(p). Accordingly, they are acceptable for inclusion into the plan. The results of our review of the Physical Security Plan will be communicated by separate correspondence.
